TERMS & CONDITIONS:

- 1. The Trust's primary object is to provide financial assistance to the family of a member of this Trust in the event of his/her death.
- 2. A homoeopathic doctor registered with the Gujarat Homoeopathic Medical Council can be a member of HBSSS.
- 3. It is mandatory to renew the registration regularly to avail of the fraternity benefit.

FRATERNITY CONTRIBUTION:

• On the death/s of any member/s, the trust office will send the intimation to each member. It will be the member's responsibility to send the requisite FC- fraternity contribution into the trust account, in a stipulated period.

DISQUALIFICATION OF MEMBERS:

- 1. If a member's fraternity contribution remains unpaid for 4 (four) months after the due date, such member shall be reminded by registered email, SMS/WhatsApp on registered Mobile. A reminder notice will be sent to the member, a period exceeding 60 days from the date of the notice, the member will be declared a defaulter and will cease to be a member of HBSSS.
- 2. If a member supplies any wrongful information in this application form or at any time during his/her membership term by which he/she violates any provision of this Trust
- 3. After the termination of membership of any member, he can rejoin this HBSSS as a new member by paying stipulated fees and deposits as may be decided by the Executive Committee.

Fraternity Benefit: (Claim procedure)

- 1. The member's nominee needs to inform the HBSSS office about the death of the member and submit the death certificate.
- 2. On the receipt of the information from the responsible person of the family of a member, that a member has become permanently physically disabled, thereby rendering him/her unfit to practice his profession. The trust office shall form a committee to verify the member's claim and will ask for the Civil Surgeon Certificate stating the member is permanently unfit to practice. Permanent disability can be out of the mental and/or physical diseases.
- 3. Amount to be paid under aforesaid sub-clauses shall be paid within 3 (three) months of the receipt of the information of physical disability or death after verifying all facts as prescribed by the Executive Committee.

RESIGNATION

• A member may resign from the Trust by giving one calendar month's notice in writing to the Secretary of his intention to do so, and upon the expiration of the notice such member shall cease to be a member of the Trust, although this will not affect his liability to pay any sum or sums due to the Trust and shall not be entitled to receive or demand any amount/fees and deposit paid by him to the Trust.

CESSATION OF MEMBERSHIP

A member shall ipso facto cease to be a member of the Trust:

- a) in case a member is an individual, if he is an un-discharged insolvent or shall make a composition or scheme of arrangement under the Insolvency Act, or if he is adjudged by a competent Court to be of unsound mind, or if he is convicted of an offence involving moral 'turpitude;
- b) In case a member was found acted against the interest of the Trust or tried to damage the reputation of the Trust.

The jurisdiction of the court is at Vadodara.
